


[Procedure to deposit GOODS AND SERVICES TAX \(GST\) through ONLINE Mode:-](#)


Goods and Services tax has to be deposited in **GSTN No. 29AAAGR0624J1Z8** through online mode only.

1. To deposit GST go to following link:- <https://payment.gst.gov.in/payment/>
